## **DESCRIPTION OF INTERNAL REVENUE DIVISION(IRD)**

BURS is responsible for administration and enforcement of the revenue laws, and other related matters. Internal revenue is one of the main divisions under BURS.

Internal revenue division is headed by commissioner Internal Revenue(CIR).

IRD is charged with the responsibility for the assessment and collection of :

Income Tax Value Added Tax Capital Transfer Tax

## Internal Revenue division units

The division has four General Managers who are/ would be incharge of the following units :

1Taxpayer service 2 Compliance 3 Technical 4 Large taxpayers

## **Taxpayer Service**

The unit is divided into four sections:

Taxpayer assistance center (TAC) Return processing Taxpayer education Management information systems

Taxpayer Assistance center is responsible for the following functions:

Enquires; it is the first stop for all taxpayers who need assistance in all the tax matters.

Filing of returns, payments of taxes and any queries. Assist taxpayers on telephone through toll free number. The unit also receives and processes registration forms. The unit also receives and processes taxpayer clearance certificate (TCC) forms. Distributes all IRD forms to taxpayers Updates BURS database with taxpayer details.

### **Return processing**

The section deals with processing of all returns for VAT ,Income tax and withholding tax. Tax returns are sent and received at this unit. Processing of returns by issuance of assessments.

# **Taxpayer Education**

The mandate of this section:

Is to educate taxpayers on all tax matters and disseminate any information necessary for tax compliance.

The section is responsible for the development of workshop materials, pamphlets, brochures etc.

### Management information systems

The unit is not yet established.

### Compliance

The section is divided into four units:

### **Risk and intelligence**

The major work of the section is to; -risk analyse cases for audit -collect data for intelligence information -man intelligence database -review intelligence information from other law instruments agencies and determine its usefulness for in-depth investigations or audit. Audit

The section deals with the following: Auditing all tax types through desk audit and field audit The aim is to check and verify compliance. Process capital transfer returns

#### Technical

The unit is responsible for the approval of superannuation funds receiving contributions from employees.
